### 1. Minutes

- District 3 Commander Keesee has been promoted and District 3 will be getting a new commander.
- Joe Ely and Tom Conis met with law enforcement to understand more detail about the Minuteman Demonstration in Congress Park on August 25. Denver Law enforcement indicated that the Minutemen have been very cooperative in organizing their demonstration.
- Literature from the Minutemen, presented by Joe Ely, suggest that they are a non-violent group.
- Joe Ely invited the President of the Minutemen Organization and the Denver police to the CPN Board Meeting in May.

#### 4. Zoning

- Rezoning
  - Wendy Moraskie reported that the application for rezoning 1300 Elizabeth & Clayton was approved.
  - o The Board had a lively discussion on the topic of rezoning and potential long term planning by the city as it related to these types of zoning applications.
- Steve's Snappin Dogs Liquor License
  - Maggie Price reported that Steve's Snappin Dogs Liquor License was granted for beer and wine.

#### 5. Membership

    additional information about the status of the project, cost of various amenities and
    feedback process.

- Jennifer Nash, guest, offered her opinion that she definitely did not want the Rec. Center in Congress Park.
