Q4 What in your opinion is the role of an RNO?

RNO's serve a number of key functions in communities: 1) They act as conveners, bringing neighbors together to discuss various issues that affect the community 2) they assess said issues and create stances via their committees or executives and then 3) advocate those positions with other stakeholders and elected officials.

Q5 What are your strategies for engaging with residents in district 10?

More needs to be done to engage all of District 10, not just Cherry Creek. Our current city councilmember believes Friday coffee's and attending the occasional RNO meeting is enough. I strongly disagree. I think a leadership committee needs to be formed of all the RNO's to discuss the major issues affecting the city e.g. homelessness, housing, the opioid epidemic, water issues, air quality, infrastructure challenges etc. I also think more frequent communication with residents is necessary to keep government transparent. I also believe digital communication is currently being underused and would love to see more community forums being held around specific subject matters and hosted by city council.

Q6 Bus Rapid Transit or BRT is currently being designed along Colfax and commercial property owners are proposing new eight story building heights and deeper lots to make building profitable. How would you respond to rezoning of residential properties to create larger commercial property assemblages and buildings?

As Colfax stretches from Capitol Hill through Cheesman and into Congress Park, I would need to discuss with the RNO's their opinions on the matter. Many are in favor of these developments along Colfax and strongly disagree with this type of rezoning anywhere else in the district. I think Colfax is ripe for development and would want to ensure that we avoid turning that part of the district into a mini RINO.

Unfortunately, due to the "strong mayor" system of governance, the mayor creates the budget and the council approves it. I would build a coalition to pressure the Mayor into dedicating a larger portion of the city budget to providing low income housing throughout the city.
